## **Career Planning**

\*\*To access Career Planning Services, there must be documentation in TCM that the individual is not able to access OOD Services\*\*

The expected outcome of Career Planning is the individual's achievement of competitive integrated employment and/or career advancement in competitive integrated employment. It is designed to be a time limited service, though no prescribed timeline is identified in rule. There must be tracking of progress and/or identification of what the team is doing to move toward this outcome.

The service and support administrator shall ensure that documentation is maintained to demonstrate that the service provided as career planning to an individual enrolled in a waiver is not otherwise available as vocational rehabilitation services.

Career planning may be provided in a variety of settings but shall not be furnished in the individual's home except when a home visit is conducted as part of the career discovery component of career planning or when the individual is self-employed and the home is the site of self-employment.

Career planning shall be provided at a ratio of one staff to one individual.

Career planning services may extend to those times when the individual is not physically present while the provider is performing career planning activities on behalf of the individual.

The county board shall authorize payment within ten calendar days of acceptance of an outcome-based report required for payment for delivery of services.
