PROCESS FOR AUTHORIZING ADULT DAY WAIVER SERVICES IN THE CPT

- 15-minute units should be authorized in UNSCHEDULED services for any of the following:
 - Individuals who require a combination of Adult Day Support or Voc Hab and any other employment service on the same day; OR
 - Individuals who are eligible for the medical and/or behavior add-on; OR
 - Individuals for whom the provider elects to receive the community integration add-on
- 15-minute units of service may be authorized using the CALENDAR for:
 - Individuals who receive less than 5 hours or more than 7 hours of Adult Day Support or Voc Hab in a single day
- Daily rate may be authorized using the CALENDAR when all of the following apply:
 - The individual receives between 5-7 hours of only Adult Day Support or Voc Hab for the same provider in a day; AND
 - The individual is not eligible for the medical and/or behavior add-on; AND
 - The provider elects not to receive the community integration add-on
